Developing the deal

- Historic Context
- Respect decision of NECA in Sept 2016
- Discussions with Government since late 2016
- Maintained a positive relationship with all North East Local Authorities and the Local Enterprise Partnership
- Focus on delivering outcomes to support the North East Strategic Economic Plan

Deal Announcement

- Budget 22 November
- 24 November Launch in Newcastle

Current Focus

- Statutory Process to create the NTCA
- Moving from deal words to delivery

Deal content - Governance

- Directly elected mayor first elections May 2019 (5 year term followed by 4 years) - Interim mayor appointed until election in 2019
- Mayor chairs Leadership Board, alongside 2 representatives per LA represents an embedded mayoral model
- NELEP representative on NT board; Mayor to sit on NELEP board
- Mayor to appoint Ambassador for Business (non voting)
- Transport governed through NT/NECA Joint Committee replicating current responsibilities and voting arrangements

Deal content: Investment fund

- Investment fund £20m revenue pa over 30 years
- Full flexibility on grant/loan mix, multi-year programming etc; early drawdown before May 2019 election
- Expect to focus on growth opportunities in energy, digital, culture/visitor economy & life sciences, and support to residents to access job opportunities

Deal content - Themes (1)

- Inclusive Growth
 - Education Improvement Challenge
 - Devolution of Adult Education Budget from 2019/20 £23m pa
 - Institute of Technology business case development
 - Work with Govt to agree and adopt an Employment Support Framework agreement, to align NT and DWP/health programmes
 - Govt support for series of pilot projects to tackle barriers to employment
- Industrial Strategy

Deal content: Themes (2)

- Housing
 - New powers to accelerate delivery of new homes and to support delivery on strategic sites led by new Housing and Land Board
 - Commitment to work towards Housing Growth Deal for North of Tyne over the coming months
- Digital connectivity and smart data
- Maximising impact of Great Exhibition of the North, including legacy
- NT Rural Productivity Plan & Rural Scale up Champion for England

Transport

- Protecting the current arrangements is central to the deal
- New Joint Transport Committee (NECA / NTCA members)
- Business as usual approach that sees the replication of the current arrangements within NECA which respects transport levies of Tyne & Wear, Northumberland and Durham
- Mayor will not have franchising powers

Governance Review - Statute


- Standard statutory process associated with the creation of any Combined Authority which includes consultation with the public and key stakeholders
- Need to illustrate the economic benefits of a new Combined Authority to the Secretary of State - independent impact report produced to help illustrate this
- Process complicated by need to leave existing North East Combined Authority (which the current NECA Leadership Board has to approve) as part of the process
