Mowbray Primary School, Stakeford Lane, Stakeford, NE62 5HQ Installation of multi-use cycle track on edge of school playing field

The emerging Local Plan had now been submitted to the Secretary of State, but this did not impact the consideration of this application. Regarding paragraph 7.19 of the report, the Highways Authority had confirmed that they had no objection to the application subject to the proposed informatives that required that no storage was allowed nor any debris allowed on the highway. Mr Sharp then continued introducing the application with the aid of a slides presentation.

There were no public speakers registered. In response to questions from members, officers responded that:

- the multi-use cycle track was for school use only
- the application had to be presented for consideration by this Local Area Council as it was a county council development.
