<p>Report on Outcomes of Statutory Consultation on Proposals for Education in the West of Northumberland This report sets out an analysis of the representations received from interested parties relating to the Council's statutory proposals for some schools in the Haydon Bridge Partnership (Bellingham Middle School and Bellingham, Kielder, Greenhaugh, West Woodburn and Otterburn First Schools and the linked non-statutory proposal for Wark Church of England First School. The Statutory Proposal was published on 10 May 2018 and opened a four week statutory period beginning on that date and closing on 7 June 2018. The Statutory Proposal set out the intention of the Council to close Bellingham Middle School with effect from 31 August 2019 and to extend the age ranges of Bellingham, Kielder, Greenhaugh, West Woodburn and Otterburn First Schools with effect from 1 September 2019. Cabinet is required in July 2018 to consider the outcomes of the statutory consultation, specifically in the light of the statutory regulations presumption against closure of rural schools, and to make the final decision on whether or not to approve the closure.</p> <p>(W. <p>North Northumberland Coast Neighbourhood Plan This report seeks approval to formally 'make' the North Northumberland Coast Neighbourhood Plan. This will bring the Plan into legal force. The Plan passed independent examination on 22 February 2018. A local referendum held in the Parishes of Bamburgh, Beadnell and North Sunderland on 24 May 2018 returned an overwhelming majority vote in favour of using the Plan to make decisions on planning applications. The Council is now obliged by statute to make the Neighbourhood Plan unless it considers that doing so would breach European Union obligations.</p> <p>Once 'made', the North Northumberland Coast Neighbourhood Plan will form part of the statutory development plan and will be used to make decisions on planning applications in the North Northumberland Coastal Area Neighbourhood Area, which is the Civil Parishes of Bamburgh, Beadnell and North Sunderland.
