Youth Service Review Update

Purpose of report.

To provide committee members with an update on the implementation of the Youth Service Review which took place in 2018/19.

Key Issues

- 1. The implementation of the youth service review has been carried out during 2019 and into 2020.
- 2. The staffing changes have now all been completed and the new management team is now in place.
- 3. Work has been completed with an external consultant in relation to vision and values which has helped the service move forward.

- 4. A common set of outcomes has been agreed which will be used in conjunction with the new electronic recording system for the youth service which will support demonstrating impact going forward.
- 5. The youth service as part of the wider adolescent service offer in Northumberland is continuing to prove beneficial allowing for integrated and flexible support to be provided for vulnerable young people.
- 6. The participation team has expanded its reach to support the participation agenda across SEND, young carers and mainstream social work teams, including taking a lead for reviewing and revamping the SEND Local Offer.
- 7. Support for VCS organisations has continued to develop across the county.

BACKGROUND

Following an external review of the Youth Service in 2017 and agreement to proceed with implementing its recommendations given by senior managers and elected members the last eighteen months have seen a number of changes made to the structure and focus of the Youth Service to bring it in line with the overall Children's Services objectives.

Internal change management processes have led to the appointment of a new Youth Service manager and a management team beneath this to support the development of the key areas of work, namely:

- Participation
- Early Help and Targeted Intervention
- Prevention

To support the development of the new management arrangements and to develop a clear vision and culture within the Youth Service an external consultant has worked with the management team and wider staff to develop a clear vision and set of values (see attached document).

This work has also supported the development of a clear set of outcomes which underpin all work the Youth Service undertakes with young people and is to be used as a base for the new electronic recording system the Youth Service will be using going forward.

The recording system will enable us to provide clearer evidence of numbers of young people being supported, where they are from, any other issues they have and the evidence of impact that the youth work intervention is having for them.

Work within the participation team has continued to grow and evolve with additional work being commissioned to support the SEND agenda, young carers and the locality social work teams.

The Youth Service lead a group of staff from the wider adolescent service in completing Return Home Interviews for young people who have been reported missing to the police. This is providing a more robust service than was available previously. This has been in place since May 2019 and was commented on as a positive development during the Joint Targeted Area Inspection in June 2019.

The Voluntary and Community youth sector has been supported in a range of ways; through supporting with funding applications, co delivery of sessions and provision of staff to run specific targeted groups. This will continue to evolve and develop according to local needs (see attached paper for more details of exact support given in each area). Link to report.

The Youth Service conducted an assessment of youth work need and existing provision across Northumberland. This has resulted in the current delivery model, which focuses the resources of the service to the areas indicating the greatest need. Factors that impacted on this included crime and anti social behaviour levels, Indices of deprivation, population density and existing VCS provision.

The current youth service provision equates to over 50 sessions being delivered each week. The breakdown below highlights the combination of involvement across the sector to provide the youth work sessions.

Working with a multi agency approach alongside other teams within Northumberland Adolescent Services and in some cases a wider agency approach including community safety teams, police and voluntary sector partners, we have been able to offer a response team to be to work remotely in various different areas of northumberland at times of need. Be this with an increase of anti social behaviour, youth substance use intelligence or a consultation of current need in an area. This response team has been able to work on these needs with a clear plan and approach in directed locations and then being able to report back on progress made.
