## SAFEGUARDING ADULTS ANNUAL REPORT - 2016/17

# **Purpose of report**

To provide an overview of the work carried out under the multi-agency arrangements for safeguarding adults in 2016/17

#### Recommendations

### **Link to Corporate Plan**

This report is relevant to the Health and Well Being priority in the Corporate Plan.

### **Key issues**

- The attached report describes the work during 2016/17 of the North Tyneside and Northumberland Safeguarding Adults Board (NSAB), and provides information about operational safeguarding activity during the year. The report describes a range of improvements in safeguarding arrangements during the year.
- There have been no cases referred for consideration for Serious Case Review in 2016/17 but the two appreciative enquiries started in the previous year were completed and reported to the Safeguarding Adults Review Committee.
- The number of Adult Concern Notifications was 1% higher in 2016/17 (4819) compared to 2015/16 (4782).
- There were 768 Safeguarding Referrals during 2016/17, 15% lower than the previous year. These figures reflect a change in the way safeguarding concerns are now being recorded in Northumberland with a decision about whether to follow procedures being made PRIOR to being inputted.
- 5 The Council has been approached to authorise 1808 cases under the Deprivation of Liberty Safeguards in 2016/17 compared to 2070 cases in 2015/16.

# Safeguarding Adults Report 2016/17

#### BACKGROUND

The County Council has strategic responsibility for overseeing multi-agency arrangements in its area for safeguarding adults at risk. This includes both arrangements for investigating and where necessary acting on referrals alleging that vulnerable adults are being abused or neglected, and wider arrangements for ensuring that the safety, independence and dignity of vulnerable adults are protected.

The attached Annual Report describes the strategic activity undertaken by the North Tyneside and Northumberland Safeguarding Adults Board, and the most significant specific issues dealt with during 2016-17 under the safeguarding adults policy and procedures. It also provides statistical information about operational safeguarding activity.
