<p>Cramlington Neighbourhood Plan</p> <p>To seek approval from Cabinet to formally ‘make’ the Cramlington Neighbourhood Plan. The Plan passed independent examination on the 16 September 2019. A local referendum held in the Parish of Cramlington on 30 January 2020 returned a majority vote in favour of using the Plan to make decisions on planning applications.
