Annex 1 - Mandatory conditions

Supply Of Alcohol (ON & OFF SALES)

- 1. No supply of alcohol may be made under the premises licence a) at a time when there is no designated premises supervisor in respect of the premises licence, or b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise); (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or
- discounted fee to the public or to a group defined by a particular characteristic in a
- manner which carries a significant risk of undermining a licensing objective:
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise antisocial behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under
- 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 6. The responsible person must ensure that-
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
- (i) beer or cider: 1/2 pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."
- 7. 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 8. For the purposes of the condition set out in paragraph 1-
- (a) "permitted price" is the price found by applying the formulawhere-
- (i) P is the permitted price.

 $P = D + (D \times V)$

- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which

enables the member or officer to prevent the supply in question
9. Where the permitted price given by Paragraph (b) of paragraph 2
would (apart from this paragraph) not be a whole number of pennies,
the price given by that sub-paragraph shall be taken to be the price
actually given by that sub-paragraph rounded up to the nearest penny.
10.-(1) Sub-paragraph (2) applies where the permitted price given by
Paragraph (b) of paragraph 2 on a day ("the first day") would be
different from the permitted price on the next day ("the second day")
as a result of a change to the rate of duty or value added tax.
(2) The permitted price which would apply on the first day applies to
sales or supplies of alcohol which take place before the expiry of the
period of 14 days beginning on the second day.

Films

- (1) Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- (2) Where the film classification body is specified in the licence, unless subsection (3) (b) applies, admission of children must be restricted in accordance with any recommendation made by that body.
- (3) Where:-
- (a) The film classification body is not specified in the licence, or
- (b) The relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question; admission of children must be restricted in accordance with any recommendation made by that licensing authority.
- (4) In this section:-

"Children means persons aged under 18; and "Film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

Door Supervision

- (1) Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, the licence must include a condition that each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in subsection (1) requires such a condition to be imposed:-
- (a) In respect of premises within paragraph 8(3)(a) of Schedule 2 to

the Private Security Industry Act 2001 (c.12) (premises with premises licence authorising plays or films), or

- (b) In respect of premises in relation to -
- (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
- (ii) Any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purpose of this section:-
- (a) "Security activity" means an activity to which paragraph 2(1) (a) of that Schedule applies, and
- (b) Paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 3 - Conditions attached after a hearing by the licensing authority

- 1. CCTV to be installed and maintained in proper working order and to the satisfaction of the licensing authority and in consultation with Northumbria Police. The system to be operational during all hours of licensable activity. Tapes are to be retained for a period of 28 days following any incident and made available to the police or the Licensing Authority on request.
- 2. A minimum of 2 SIA registered door staff are to be employed from 21:00 until the terminal hour each Friday, Saturday and public holiday and each day preceding a public holiday.
- 3. The outside drinking area to the front to be cleared by 22:00 each day.
- 4. No drinks promotions will be permitted, ie the licensee will not advertise, promote or supply alcoholic drinks in such a way that it is intended or likely to encourage persons to consume alcohol to an excessive extent.
- 5. The licensee shall not supply alcoholic drinks at a reduced price during any limited period on any day. Reduced price means:
- a) at no cost to the customer
- b) by way of exchange for any ticket or voucher
- c) by inclusion of the price of an alcoholic drink in some other charge or payment for a product, goods or services such as with a

mixer, food or entrance charge

- d) a price less than that being charged during an earlier period of the same day
- e) in such a way whereby types, brands and mixtures of drinks are sold either singly or in multiples, at a price for greater measures or quantities than those same drinks being sold for the same price but in smaller measures or quantities during an earlier or later period of the same day
- 6. No admittance to the premises after 23:30.
- 7. Proof of age scheme to be adopted.
- 8. To be an active member of pub watch and attend meetings.
- 9. Northumberland Drugs Policy to be introduced [correct name of the policy to be confirmed]
- 10. The premises personal licence holder/designated premises supervisor shall ensure that no public nuisance is caused by noise emanating from the premises or vibration transmitted through the structure of the premises.
- 11. The premises personal licence holder/designated premises supervisor shall ensure that the entrance door from the rear patio on the east side of the building remain closed at all times of regulated entertainment (except during disabled access/egress) to prevent noise emanating from the premises which is likely to give rise to a public nuisance.
- 12. The premises personal licence holder/designated premises supervisor shall ensure that the door between the rear function room and the passage is fitted with a suitable working self-closing device to prevent noise emanating from the premises which is likely to give rise to a public nuisance.
- 13. The premises personal licence holder/designated premises supervisor shall ensure that the rear patio on the east side of the building is not accessed and occupied by members of the public during the hours of 20:30 to 11:00 (except during disabled access/egress).
- 14. The premises personal licence holder/designated premises supervisor shall provide clear and legible notices to be displayed at prominent positions adjacent to exits and other circulatory areas requesting patrons to leave the premises having regard to the needs of local residents, in particular emphasising the need to refrain from shouting, slamming car doors and the sounding of car horns. The design and appearance of such notices to be approved by the Licensing Authority.
