Annex 1 - Mandatory conditions

Supply Of Alcohol (ON & OFF SALES)

- 1. No supply of alcohol may be made under the premises licence a) at a time when there is no designated premises supervisor in respect of the premises licence, or b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children
 - a) games or other activities which require or encourage, or are designed to require or encourage, individuals to- i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supplied alcohol), or ii) drink as much alcohol as possible (whether within a time limit or otherwise); b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act); c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less; d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on- i) the outcome of a race, competition or other event or process, or ii) the likelihood of anything occurring or not occurring; e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise antisocial behaviour or to refer to the effects of drunkenness in any favourable manner.
- 4. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 6. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 7. The responsible person shall ensure that- a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures- i) beer or cider: ½ pint; ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and iii) still wine in a glass: 125 ml; and b) customers are made aware of the availability of these measures.

Films

Admission of children to the exhibition of any film must be in accordance with the recommendations of the British Board of Film Classification for that film. Where permission has been given by the Licensing Authority to show a film not classified by the British Board of Film Classification, the requirements made by the Licensing Authority for the admission of children to the exhibition of that film must be followed.

Door Supervision

Any premises which includes a condition that door supervisors must be at the premises to carry out a security activity, shall ensure that each such person is licensed to conduct such activities by the Security Industry Authority.

Annex 2 - Conditions consistent with the operating Schedule

THE REGULATORY REFORM (SPECIAL OCCASIONS LICENSING) ORDER 2002 (ALSO KNOWN AS "36 HOUR RULE")

Provided licensee has converted his rights, he can remain open for a 36-hour period over the New Year. The premises can remain open for a period not exceeding 36 hours from commencement of trading on 31st December until termination of trading on 1st January in any given year.

The effect of the Order is to allow premises in respect of which there are Special Occasions licensing hours, and in respect of which there is an entertainment licence in force, to be kept open on New Year's Eve and during the Special Occasions licensing hours for any purposes authorised by the entertainment licence beyond the time authorised by the licence itself.

EMBEDDED CONDITIONS

PUBLIC ENTERTAINMENT LICENCE (BVBC) WHICH CAN BE "EMBEDDED" AS CONDITIONS IF THE PREMISES HAD A PEL AND CONVERTED IT OVER TO A PREMISES LICENCE

1. The maximum number of persons allowed to be present in the premises at any one time shall be as follows:

All purpose -160

- 2. This licence is issued subject to the terms and conditions specified below:
- a. Except as permitted by any Special Hours Certificate granted by virtue of Section 77 of the Licensing Act 1964, as amended (which applies only to premises licensed for the sale of intoxicating liquor), the licensee shall NOT open or use the said premises for PUBLIC MUSIC OR DANCING ON EASTER SUNDAY, CHRISTMAS DAY OR GOOD FRIDAY without first obtaining from the Borough Council an occasional licence (Temporary Event Notice) granting exemption.

The premises will be permitted to open for licensable activities to show the broadcast of televised sporting events of national or international interest outside normal operating hours. Such opening times for this purpose to be confirmed upon 7 days prior notice in writing to the police before the premises intend to open, such notification to include the opening times and the sporting event, which is to be shown.

Health and Safety

- The electrical installations must comply must comply with any applicable rules and regulations
 affecting the use of electricity for the time being in force. All electrical installations shall be inspected
 once a year by one of the following:
 - A chartered electrical engineer, or
 - A member of the electrical contractors association, or
 - A certificate holder of the national inspection council for electrical installation contracting, or
 - The local electricity board, or
 - Such other persons as may from time to time be approved by the council.
- 2. The licensee shall ensure that a residual current device (RCD) is permanently installed into the electrical supply system of the premises or as a minimum an RCD is permanently fitted into all electric circuits that are likely to be used by performers and /or any others using or hiring the premises.

- 3. Any premises using or employing door supervisors mist keep a work and incident record on the premises and all supervisors must be registered with the S.I.A. These records must be made available to all relevant authorities for inspection on request.
- 4. Any duly authorised officer of the council shall be given free access to these premises at any time for the purpose of ensuring compliance with any conditions and/or the safety of the public attending any event at these premises.
- 5. Any beer garden or other external area used by the public at these licensed premises shall only be used during daylight hours or shall be suitably lit to allow safe access and egress from the area.
