## **PART II**

### **3. REPORT OF THE HEAD OF PUBLIC PROTECTION**

#### **Case 05/04/18/381**

The Licensing Manager introduced the report and explained that an application had been received which officers were unable to deal with under delegated powers.

The applicant was asked to confirm his address.

The Sub-Committee was asked to consider the application and the applicant's representations along with the written and oral report of the Licensing Manager and relevant law and guidance policy to determine whether or not the applicant was a fit and proper person to hold such a licence. It was stated that the burden of proof rested upon the applicant and the standard of proof rested upon the civil standard of proof.

The licence holder submitted his case in support of his application and then answered questions from the sub-committee.

Members of the sub committee remained in the meeting to deliberate and make their decision and all others, except the legal advisor left the room.

When all were asked to return to the meeting the Chair declared on behalf of the sub committee:

The sub committee have considered all representations before them and have determined to **GRANT** the private hire driver's licence.

#### **Reasons:**

- 1) Although sub committee took the speeding offences very seriously, on this occasion the offences had taken place in the applicant's personal vehicle and not in a licensed vehicle, there were two offences to come off his licence in a few months and therefore they deemed him to be a fit and proper person.

The applicant was not in attendance and had requested that the application be deferred to a future meeting. The application was deferred to the next sub committee to give the applicant an opportunity to attend.

**RESOLVED** members agreed that the applicant be invited the Licensing & Regulatory sub committee on 31 May 2018.

The Licensing Manager informed the sub committee that an issue had arisen associated with the licence holder's suitability to continue to hold a hackney carriage driver's licence.

The applicant had requested an adjournment to a future meeting to be held in the afternoon due to a medical condition.

**RESOLVED** members agreed that the applicant be asked to provide a full medical report within 28 days or, the hackney carriage driver's licence would be suspended until such a report was received by the Council.
