PETITION - REMOVAL OF TRAFFIC CALMING, ALLERBURN LEA, ALNWICK

Purpose of report

To respond to the petition received by the North Northumberland Local Area Council regarding residents request to remove speed cushions from Allerburn Lea in Alnwick.

Recommendations

It is recommended that the contents of this report be noted and that Local Area Council supports the decision that the traffic calming features should remain in place and the petitioners request declined.

Key Issues

- 1. A petition has been received requesting the removal of traffic calming in Allerburn Lea.
- 2. Consultation was previously carried out on removing traffic calming as part of a resurfacing scheme.
- 3. There is no majority in favour of removing the traffic calming.

Introduction

On 13th January 2019 the County Council received a petition of 72 signatures from residents of Allerburn Lea requesting the removal of traffic calming features from the estate.

The petition was submitted following previous discussion between the lead petitioner, Officers and Councillor Moore. It states:

"It would however seem that the Council has not complied with Department of Transport Guidelines on Traffic Calming nor the Road Humps Regulations, since:

- a) It had no evidence that there is a speeding problem.
- b) It failed to consider other types of traffic calming
- c) It failed to consider the risks in the location of the road humps, so failing its duty of care.
- d) It failed to properly consult.

The residents of Allerburn Lea therefore require the removal of the speed humps.

Please find attached three pages of signatures from residents."

Background

Allerburn Lea is a residential estate of 205 houses which was developed in stages from the 1990s onwards. The roads within the estate, including traffic calming features, were constructed by the developer before being adopted as public highway by the County Council from 1998 onwards.

There are three different types of traffic calming feature within the estate. These are shown in the photographs below:



Speed Cushions

These are located on the main road through the estate and are designed to allow access by large vehicles such as buses which can 'straddle' them.



Speed Humps

These are constructed of blocks and are located at the entrances to cul-de-sacs in the earlier stages of the development.



Rumble Strips

Also constructed from blocks these are located at the entrances to cul-de-sacs in the later stages of the development.

As stated above, these traffic calming features were installed by the housing developer <u>before</u> the roads were adopted by the County Council. The features met the requirements of the traffic calming regulations in place at the time of adoption.

Road Resurfacing

In 2017, a resurfacing scheme was planned for part of the estate. The scheme required the existing traffic calming to be removed along with the old road surface. As is normal

practice when a road with traffic calming features is due to be resurfaced, the opportunity was taken to consult the affected residents to find out whether they wished to retain the traffic calming or not.

37 responses were received. Of those:

- 17 stated the speed humps should not be put back, (46%)
- 18 stated the speed humps should be put back, (49%)
- 2 did not state a preference, (5%)

It was therefore decided that the speed humps should be put back in place as part of the resurfacing scheme.

Specific Issues Raised in the Petition

The petition claims that the County Council failed to comply with Traffic Calming Regulations because:

- a) It had no evidence that there is a speeding problem.
- b) It failed to consider other types of traffic calming
- c) It failed to consider the risks in the location of the road humps, so failing its duty of care.
- d) It failed to properly consult.

All of the above factors apply when <u>new</u> traffic calming features are being considered in an area where there is none currently. In this instance, the traffic calming features were simply being put back following a resurfacing scheme. a) to c) therefore do not apply.

In terms of d), consultation, those residents directly affected were consulted and there was a slight majority in favour of keeping the speed humps.

The speed humps that were reinstated following resurfacing have been constructed in accordance with the Traffic Calming Regulations set out in Local Transport Note 1/07.

Other relevant points to note include:

- The County Council will only consider removing traffic calming features if a clear majority of residents are in favour.
- The current petition of 72 signatures is only 35% of potential signatures, assuming one per household.
- If a majority in favour is demonstrated, a budget would need to be identified through the Local Transport Plan process and the proposal would require the support of either the local ward Members and/or Alnwick Town Council.
- The estate roads were designed to include traffic calming from the outset.
- The residential nature of the area, including families with young children and the presence of a play area mean that traffic calming is considered appropriate.

1			Yes, please remove the speed cushions when the resurfacing is carried out. They are ineffective as a speed reduction measure and just serve to force cars towards the centre of the road as well as increase the chance of damage to tyres and suspension.

1			Yes remove the "Speed Humps". This is two votes from number 9. At any time a 20mph speed limit is proposed we would vote for that too.
1			I support the proposal to remove the speed cushions.
1			We agree with the removal of the speed humps that are in place at present. The reason being they are too narrow to deter the minority who drive excessively fast and they simply straddle the humps. We have always been a supporter of the Twentys Plenty and enquired if this alternative is a possibility to the existing arrangement. Statistics bare out the reduction in serious injuries while doing twenty mph max. If this is not possible then to reduce speed I can only say the speed humps actually need an increase in size to deter the few that do drive above the safe limit through the estate.
1			I would like the speed cushions to be removed.
	1		Of cause I support the programme to resurface Allerburn Lea through I think it should be the whole road down to Denwick lane. So far as the speed cushions are concerned these outside number 1 Allerburn Lea are essential if not made more effective. There have been complaints about the speed of vehicles both entering and leaving Allerburn Lea in recent weeks. It has reached a serious level - perhaps those lines of stones now being used at Alnmouth would solve the problem. I should point out that is is difficult to get out of my drive at number 1 because cars come over the brow of the hill at such high speeds and this is with calming in place.

	1		1 Please retain speed bumps. 2 Impose 20mph throughout the estate. 3 Consider double yellow lines at junction of Alberbury Lean and Denwick Lane at least on one side. 4 Consider the view of the road at the junction of Allerburn Lea and the road leading to Allerburn House and the proposed housing development.
1			A 20mph limit would be better than speed humps. The one outside of number 90 causes problems in icy weather to those cars coming up the hill
	1		We would prefer to keep the existing speed cushions but a better ones than they are now. We would also like a 20mph speed limit especially as where we live at the 1st phase - cars and vans come up from bottom of the estate very quickly.
1			Speed bumps removed but only if speed limit signs put up throughout estate, and possibly children playing signs
	1		Request that the Speed Cushions are RETAINED. Road Specification on the steeply inclined sections needs to be fit for purpose. It is currently not in cold / freezing weather conditions with significant risk of skidding.
1			As you are aware I have requested that the speed cushions be removed from outside of my property due to cracking occurring in the internal walls. Vibration testing was carried out and some abnormal readings were noted. Also in the bad weather owners of the properties at the bottom of the estate get stuck at the speed cushions outside of my property. If the speed cushions are not removed perhaps the one outside of my property could be moved elsewhere. I am sure that if other owners experienced cracking in their walls they would want them removed!
	1		Should keep some traffic calming in place as some residents drive too fast on the top part of the road making it tricky to get on and off your drive if you live in one of the first houses in the road.

1			I am very happy to have this section of the road resurfaced but I do not want any traffic calming.
1			Given the twisting nature of the centre section of the estate, and the presence of a children's play area I feel there should be 1 set of speed bumps at the entrance and a 20 mph limit imposed throughout. There are always cars parked on the road creating hazards for passing vehicles. Many cars come up the hill too fast into the bends. Please consider removing the speed bumps except at the entrance.
	1		I am delighted to see that the resurfacing is to be carried out, the surfacing done by the original developer was I have to say of a poor quality. Regarding traffic calming measures, I believe these should be retained and indeed enhanced if possible. Our house fronts onto this road and the excessive speed at which some of the younger residents and indeed not so young go I am surprised that an accident has not already occurred, particularly with all badly parked cars on this road. There are a considerable number of under 10s live in the area and I would fear for their safety if the traffic calming measures were abolished.
1			Speed cushions do not slow traffic. 10 mph sign on each lamp post. Digital speed signs. Flyers in post to slow traffic? (speed aware) as a warning. As traffic in phase one area is too fast!!
