(1) First Stage Investment Strategy Review

The report provided information about the first stage of NCCPF's 2019 investment strategy review which had been undertaken by Mercer and enclosed with the papers.

RESOLVED that:

- (a) The report be accepted; and
- (b) Delegated authority be given to the Service Director Finance, in consultation with the Chair and Vice-Chair of the Pension Fund Panel, to amend the geographical split of the Fund's equity allocation, changing the allocations in two or more tranches, the timing of which would be determined following discussion with LGIM, as follows:

UK Equity	20%
North American Equity	16%
Europen Equity	15%
Japanese Equity	12%
Asia Pacific (ex Japan)	12%
Emerging Market Equity	12%
RAFI	13%

(c) Should a second stage of the investment strategy review be needed, it be undertaken at a later date.
