Welcome from the Chair

Well, the big RE news is the publication of the RE Commission's final report (see item 2 below). I responded with this **statement** on the day of publication. However, it is still business as usual for SACREs up and down the country. I know that Lewisham is launching a new Agreed Syllabus this term, and three Bedfordshire SACREs are launching their collaboratively written syllabus. Do let us know what your SACRE is doing!

A number of SACREs continue to have concerns about funding. As we have stated before, in 2017, Nick Gibb MP, Minister for School Standards, made a commitment that SACREs and Agreed Syllabus Conferences will continue to be funded by central government, through the central school services block (CSSB), which is one of the blocks in the national funding formula. We are concerned that there appear to be very large variations between local authorities in the proportion of this government grant that is spent on the work of SACREs, but there is little hard data about this. We are therefore asking you to complete a short survey on LA funding of SACREs, which is intended to enable us to build up a national picture, so that we can tell each SACRE whether they are relatively under (or over) funded.

You can see how much the total CSSB for your LA is here.

Please ask your LA what the total spend for SACRE was in the financial year 2017-8 and what the LA planned total spend is for 2018-9 and let us know by December 1st. There should be a budget line in your LA's accounts. We think this figure is likely to include adviser and clerking costs, as well as costs to do with any other activity your SACRE is involved in. Please then complete this survey by 1 December. This data will be published anonymously.

NASACRE is also aware that many Agreed Syllabus Conferences may wish to adopt and adapt to local contexts an Agreed Syllabus from another SACRE area, rather than write their own. Other SACREs may have a syllabus that they are eager to share either for a payment or for free. In order to facilitate this, we are planning on including a list of available Agreed Syllabuses in future SACRE briefings. If you have a Syllabus that you would be willing to share, please email the chair with the SACRE name, syllabus name, date it was written and what it would cost another SACRE to adopt either in full or in part.

Commission on Religious Education report: 'Religion and Worldviews: the way forward'

The highly anticipated **report** was published on 9 September and much has already been written about it. Please highlight it at your next SACRE meeting.

NASACRE Exec met on 13 September to discuss this report, and we offer some **comments** to provide 'food for thought' for your individual SACRE discussions. There are also some suggested **questions** which you might find useful to help guide your discussions.

PLEASE NOTE: the CoRE report is NOT statutory and therefore all SACRES and Agreed Syllabus Conferences should continue to operate as before. All Agreed Syllabi must still be implemented and reviewed in line with current legislation.

'A New Settlement Revised' report - July 2018

NASACRE Executive

There has been some confusion about the Executive board of NASACRE not being representative of different faiths, local government etc as on a SACRE. In point of fact, the current Executive is very diverse, but this is not because they represent their different faiths or SACREs on NASACRE. NASACRE, being the national association of SACREs, is not a SACRE responsible for a country rather than a local area, but a body devoted to assisting, representing, aiding in the development of, and advising, local authority SACREs.

Recently, in an effort to enhance its efficiency, NASACRE has asked that, in addition to the usual officers, members of the Executive should offer certain skills, such as communications, conference planning, or development. SACRE members are nominated by their respective faith group, council etc and part of their responsibility is to represent that religion, profession, or government body. However, this is not the case with NASACRE.

Of course, there are similarities between NASACRE and SACREs. All these bodies are committed to furthering the best possible religious education (and collective worship) for all children and young people in all schools.

Westhill Awards

Over the last thirteen years, the Westhill/NASACRE Awards have successfully given SACREs opportunities to enhance their capacity to generate high quality experiences in RE (or collective worship) for their schools.

NASACRE is now encouraging and inviting individual SACREs (or SACREs in partnership) to apply for a Westhill/NASACRE Award for 2019-20. Awards of up to £4,000 may be applied for via the **application form** on our **website**.

Projects should offer school pupils the opportunity to engage in compelling learning experiences in RE (or collective worship), within the broad theme of "education into diversity".
