5. MINUTES

RESOLVED that the minutes of the meeting of the Standing Advisory Council on Religious Education held on 7 March 2018, as circulated, be confirmed as a true record and signed by the Chairman.

6. AN UPDATE OF CONTACTS WITH SCHOOLS AND TRAINING PROVISION

The SACRE members received an update from Mr Phil André, RE Consultant, about his provision of RE in-service training and contacts with schools since the last related meeting (a copy of which is filed with the signed minutes as Appendix B).

Phil André drew the attention of members to the discussions with the head of RE at The Duchess High School about the requirements for the new RE GCSE. It was reported that a number of secondary RE teachers worried that the emphasis on scripitual analysis and reduced opportunities to address topical ethical issues would undermine student enthusiasm for the subject. Discussion took place on what the SACRE could do to help and support teachers in their concerns. The Chairman suggested a letter be drafted to the Department for Education and GCSE awarding bodies from the SACRE to outline the concerns of teachers regarding the new RE GCSE.

Regarding 29.3.18, Ms Khan informed members that she was to liaise with the mosque and Seaton Sluice Middle School to arrange a visit. She noted the number of requests received from schools wanting to discuss Islam which was very positive.

RESOLVED that the report be received.

7. NORTHUMBERLAND SACRE NEWSLETTER

(a) Members received a copy of the 37th issue of the Northumberland SACRE Newsletter, dated April 2018, that had been circulated to all schools and is published on the schools' website (a copy of which has been filed with the signed minutes).

Councillor Pidcock reported that there was to be another Holocaust Memorial event at County Hall, Morpeth. A working group had been established to discuss arrangements for the event. The working group had agreed that the event next January was to focus entirely on the Holocaust. However, it was noted that nationally it had been confirmed that there was to be an emphasis on not only the Holocaust but other genocides at Holocaust Memorial events. It was confirmed that an invitation was to be sent to all members of the SACRE nearer the time regarding County Hall's event.
