5. MINUTES

RESOLVED that the minutes of the meeting of the Standing Advisory Council on Religious Education held on Wednesday, 24 April 2019, as circulated, be confirmed as a true record and signed by the Chairman.

6. COMMISSION ON RELIGIOUS EDUCATION (CORE) REPORT

Members welcomed Dr. Joyce Miller to the SACRE to discuss the outcomes of the Commission's report. A copy of the powerpoint presentation has been filed with the signed minutes.

Members were advised that the Commission on Religious Education (CoRE) was established to review the legal, educational and policy frameworks for Religious Education, by a wide-ranging, inclusive and evidence-based process designed to inform policy makers about these areas. The ultimate aim was to improve the quality and rigour of RE and its capacity to prepare pupils for life in modern Britain.

Joyce reported that in September 2018, the Commission released its final report, Religion and Worldviews: the way forward. The report set out a National Plan for RE comprising of 11 recommendations, and called on the Government to consider and adopt it.

The CoRE had spent two years listening to evidence from a wide range of concerned parties including pupils, teachers, lecturers, advisers, parents and faith and belief communities. Over three thousand submissions were received. In this, its Final Report, CoRE therefore proposed that a new National Plan for RE should be enacted to ensure that learning in this area remained academically rigorous and a knowledge-rich preparation for life in a world of great religion and belief diversity.

The powerpoint presentation covered the following areas of discussion:

- The current RE challenges both 'educational imaginary' and 'national imaginary'.
- Policy and principles of RE.
- The two main topics; Policy and Professional Practice.
- Policy recommendations and the four key areas in which change is needed: the subject name, a national entitlement for all, changes to the law and the creation of Local Advisory Networks, and the withdrawal of pupils and students.
- The proposed change of subject name to Religion and Worldviews and how this could let RE become more fluid, dynamic and more up to date with current issues across the world.
- The changes to the law that would amend legislation regarding SACREs. In place of SACREs there would be Local Advisory Networks and what these new bodies could look like.

- The three Practice recommendations.
- The realisation that many local authorities pay a third party to write their RE agreed syllabus or copied from a pre-existing one.
- The recommendation to set up a new national body to write some exemplary
 programmes of study that schools could use. It was noted that within the
 recommendation it was clear that the people on that body should be there
 because of their expertise in RE, and not because they were there representing a
 religion.
- The proposal to increase all RE Initial Teacher Education (ITE) and CPD opportunities.
- The need for schools to recognise that children's spiritual, moral, social and cultural development was a cross-curriculum requirement. It should be a whole school issue. It was felt that the role or responsibility should not fall within one subject or on one teacher.
- The need for accountability, but this could be achieved by introducing a National Entitlement.
- Joyce's own views and experience of teaching RE.
- The ambition to make RE exciting, relevant and not restrictive or bounded.
- Criticisms and responses. It was noted that there had been support for the recommendations from NATRE, NAHT, C of E and REC. However there had been criticism from the Roman Catholic Church and the Board of Deputies of British Jews.
- Where now and how to make RE relevant for pupils who have no connection to or interest in organised religion?
- Following on from the report what had the commission learnt and what could have been done better?
- The difficulties faced in trying to bring around change and could the new Ofsted framework offer support?

Following on from the presentation and discussion members of the SACRE were asked what they wanted to take from the CoRE report. Members agreed that they should consider ways of implementing recommendations they liked from the report. It was suggested that an agenda item be placed on the next meeting of the SACRE to discuss further. It was also suggested that an article about Joyce's visit be in the next SACRE newsletter.

RESOLVED that the information be noted and a thank you extended to Dr. Joyce Miller for attending the Northumberland SACRE.

7. AN UPDATE OF CONTACTS WITH SCHOOLS AND TRAINING PROVISION

The SACRE members received an update from Mr. Phil André, RE Consultant, about his provision of RE in-service training and contacts with schools since the last related meeting (a copy of which is filed with the signed minutes as Appendix B).
