

# **Budget Context**

- Savings identified of £9.8m for 20/21 & work ongoing on 21/22.
- Increasing demand for services.
- Transition team driving service integration.
- Minimise impact on frontline services.




## **Provisional Local Government Finance Settlement**

- A one year settlement as Fair Funding Review has been delayed until 2021-22.
- Grant funding remained largely the same as 2019-20 with some additional one off funding.
- Social Care Funding £9.9 million for Northumberland.
- Basic Council Tax referendum limit 1.99%.
- ASC Precept referendum 2%.

# Summary

- Our budget position, whilst challenging, is under control £21.7 million savings.
- Through managing debt better, revising assumptions around social care and local government reform, we've reduced the savings gap.
- The organisation is in much better shape to do more, with less.
- Financial prospects remain extremely challenging.
- Increased costs and growing pressures in demand remain, particularly in adult and children's services.
- Tough decisions still to be made but remain committed to protecting the most vulnerable where possible.
- Ambitious for our future with targeted £677 million capital investment programme.
- Investment from North of Tyne Devolution Deal will really make a difference to people's lives.
- Borderlands Growth Deal could act as a catalyst for further investment.
- Determined to shine a light on all that is great about Northumberland as a place to work, live, visit and do business.
