Response to Petition for Dogs on Leads at Newbiggin-by-the-Sea Promenade.

Report of: Elizabeth Morgan Interim Executive Director for Public Health and Community Services.

Cabinet Member: Colin Horncastle

Purpose of report

To respond to a recent petition requesting that measures be put in place to require all dogs to be placed on leads while being exercised on Newbiggin-by-the-Sea Promenade.

Recommendations

1. To publicly consult in September 2022 on adding this measure (that dogs must be placed on leads on Newbiggin Promenade) in January 2023 to the existing Northumberland County Council (Dog Control) Public Spaces Protection Order.

Link to Corporate Plan

This report is relevant to the "Keeping Our Communities Safe and Well" priority included in the NCC Corporate Plan 2018-2021

<u>Key issues</u>

- The petition asks for consideration to be given to a new restriction requiring all dogs to be placed on leads while being walked on Newbiggin by the Sea promenade. The petitioners think this measure should be in place is due to aggressive dogs and unhelpful owners detracting from what should be an enjoyable experience for families and individuals using the promenade.
- The existing Northumberland County Council (Dog Control) Public Spaces Protection Order (PSPO) is required to be renewed under statutory provision in January 2023. Before its renewal, public consultation must be undertaken on any existing or proposed measures and it is planned that this consultation will begin September 2022.
- 3. It is proposed that this request, requiring all dogs being placed on leads while being exercised on Newbiggin-by-the-Sea Promenade be included as part of the proposed consultation.
- 4. The current PSPO already allows officers to instruct dog owners to put dogs on leads if they think the dog is out of control. There will be heightened patrolling of the Promenade during 2022. This will also assist in building up evidence to support the need for such a measure as proposed by the petitioners.

<u>Background</u>

- Since 2012 the Council has had a zero-tolerance approach to dog fouling. Any
 person observed allowing their dog(s) to foul without immediately picking up is (if a
 first-time offender) issued with a fixed penalty notice. This requires the payment
 within 14 days but if the offender does not pay the fine (£100 standard) or is a
 second time offender then the council would prosecute through the courts. The
 current NCC (Dog Control) Public Spaces Protection Order (PSPO) makes it an
 offence to foul any publicly accessible land in Northumberland.
- 2. The current NCC (Dog Control) Public Spaces Protection Order (PSPO) only requires dogs to be on leads beside A & B class roads and while in cemeteries/memorial gardens. However, the PSPO also allows Officers who witness poor dog control to order dogs be placed on a lead on any public land. This gives Enforcement Officers the power to direct a dog owner to put their dog on a lead if we feel it is out of control, behaving in a dangerous manner or causing a nuisance but we must be there to see it.
- The PSPO also has in place a beach exclusion zone for areas of Blyth and Newbiggin Beaches which is enforced between 1st May and 30th September each year.
- 4. As part of the Green Dog Walker Scheme the Council offer members bags for the safe removal and disposal of dogs faeces. They are available for free at Council offices and are distributed by animal welfare officers during patrols of public spaces. The scheme currently has over 4000 members.

PETITION – B1523 SOUTH NEWSHAM ROAD, BLYTH

Report of: Service Director - Local Services, Paul Jones

Cabinet Member: John Riddle

Purpose of report

To acknowledge receipt of the e-petition received by Democratic Services regarding road safety on the B1523 South Newsham Road, Blyth.

Recommendations

It is recommended that the Local Area Council note the content of this report and support the actions proposed.

Link to Corporate Plan

How - "We want to be efficient, open and work for everyone" Enjoying - "We want you to love where you live" Connecting - "We want you to have access to the things you need"

Key Issues

- 1. A petition has been received requesting that traffic calming measures are introduced as the petitioner considers the majority of road users do not abide by the speed limit.
- 2. The petition states that there have been several accidents, and it is felt that it only a matter of time before there is a serious accident to a member of the public. It also states that there have been near misses witnessed which have involved school children on their way home from school.
- 3. Volume of traffic is also raised as a concern; it indicates recent new builds have only increased the problem. The petition states this will only become worse when the proposed Northumberland Line is operating.
- 4. This online petition has been signed by 78 signatories.

- 5. We note the issues raised in the Petition. Councillor Humphrey has already allocated some of his Members Local Improvement Scheme allowance into some preliminary design options to address some of these issues and we will be undertaking some preliminary design work to look at potential solutions.
- 6. There are significant highway works proposed affecting this road as part of two planning applications.
- 7. New speed and camera surveys to be carried out to .
- 8. Continue to work with Road Safety Unit at Northumbria Police to agree appropriate enforcement of speed limit.

Background

The Petition

The County Council has received a 78 name petition stating that :-

"The B1523 road needs to have speed calming measures in place as the majority of road users do not abide by the speed limit, there have been several RTA and I feel it is only a matter of time before there is a serious accident to a member of the public in the recent weeks I have witnessed two near misses on the road which involved children on their way home from school.

"Not only the high speeds, which is a massive issue we also have the additional volume of traffic from all the new builds in this area along with the extra traffic which will happen when the train link is operational the road is ridiculously busy now, can you imagine how bad it will be with this additional traffic morning and night."

Initial Comments

Northumberland County Council would like to thank the lead petitioner for their work in putting the petition together. We note the issues raised.

Councillor Humphrey has already allocated some of his Members Local Improvement Scheme allowance into some preliminary design options to address some of these issues.

There are ongoing developments in the area which include works to the road layout and these will need to be taken into account in any future works.

In response to the petition we have examined the accident data and speed survey information for the road which is set out below.

Accident Data

According to accident data from Northumbria Police, there have been no personal injury collisions on B1523 South Newsham Road between Cottingwood Green and the roundabout at the A1061 junction in the last 5 years.

The only recorded accidents in the vicinity were two serious accidents which occurred in 2021 at or on the approach to the A1061 roundabout.

- 2 -

In March 2021, a car travelling east on Laverock Hall Road, approaching the roundabout applied its brakes in accordance with other traffic. The rider of a motorcycle following had a momentary lapse of concentration and collided with the car causing the rider to propel over the handlebars causing a suspected fracture to their right arm.

In July 2021 a cyclist was travelling along Laverock Hall Road and entered the roundabout. A car has also entered the roundabout failing to see the cyclist causing them to collide with the car.

It should be noted that Northumbria Police only record details of injury accidents and we are unable to provide any information on any damage only incidents, or any near misses which may have occurred.

Speed Surveys

Our most recent speed survey was carried out in June 2019 at the southern side of Park Farm, a summary of the results are as follows:-

Northbound Vehicles

Average Daily Vehicles	85 th Percentile	Average Speed	Highest Recorded Speed
4495	35.3mph	30.9mph	46-51mph (8 vehicles)

Southbound Vehicles

Average Daily Vehicles	85 th Percentile	Average Speed	Highest Recorded Speed
4641	34.4mph	29.9mph	46-51mph (4 vehicles)

Note:- The 85th percentile is that speed at which 85% of vehicles are travelling (or less). The remaining 15% of vehicles will be travelling above that speed.

It is recognised that traffic flow and vehicle speeds may have increased since this survey was carried out. A new speed survey is planned and once new data is available, this can be considered in deciding future actions.

A camera survey is also planned to assess current behaviour and the potential risk to pedestrians and other vulnerable road users.

The concerns regarding excessive vehicle speed have been passed onto the police for further investigation for any appropriate enforcement action.

Planning Applications

There are two developments which will involve highway works along this length of road.

Land South West of Park Farm – Planning Ref: 20/04131/REM

This development includes the following highway works:

- Provision of two new priority junctions to access the development from the B1523
- Widening of the B1523 to allow for ghost island right turn pockets into the existing Park Farm Villas and to the new estate
- Provision of pedestrian refuge island to the North of Park Farm Villas.

Northumberland Line, South Newsham Station – Planning Ref: 21/03720/CCD

This development proposes the following highway works:

- Remove the existing roundabout linking the B1523 and the A1061.
- Provide a new larger roundabout to the West of the existing roundabout.
- Re-align the B1523 to align with the new roundabout.
- Provide a new priority junction to the station car park on off the re-aligned B1523.

As noted, Councillor Humphrey has already allocated some of his Members Local Improvement Scheme allowance into some preliminary design options to address some of the issues raised in the petition.

However, given the future highway works noted above, it has been agreed that relatively small-scale improvements would be considered in the short term until the effects on traffic of the new highway works can be seen. These improvements could include :-

A) improved signage and road markings,

B) bolt down traffic calming measures which can be removed as necessary, and,

C) additional interactive signs

Proposed Actions

- A) Carry out new speed survey to assess how vehicles numbers and speeds may have increased since 2019 when previous survey was carried out.
- B) Carry out camera survey to assess current behaviour and potential risk to pedestrians and other vulnerable road users.
- C) Proceed with preliminary design work funded through Cllr Humphrey's Members Local Improvement Scheme allowance to identify appropriate small scale improvements.
- D) Continue to work closely with the Road Safety Unit at Northumbria Police to agree enforcement action.



TERMS OF REFERENCE

- (a) To enhance good governance in the area and ensure that the Council's policies take account of the needs and aspirations of local communities and do not discriminate unfairly between the different Areas.
- (b) To advise the Cabinet on budget priorities and expenditure within the Area.
- (c) To consider, develop and influence policy and strategy development of the Council, its arms-length organisations, and other relevant bodies, to ensure that they meet local requirements and facilitate efficient and transparent decision making.
- (d) To receive information, consider and comment on matters associated with service delivery including those undertaken in partnership agencies, affecting the local area to ensure that they meet local requirements, including matters relating to community safety, anti-social behaviour and environmental crime.
- (e) To consider and refer to Cabinet any issues from a local community perspective with emerging Neighbourhood Plans within their area, and consider local planning applications as per the planning delegation scheme
- (f) To consider and recommend adjustments to budget priorities in relation to Local Transport Plan issues within their area, and to make decisions in relation to devolved capital highway maintenance allocations.
- (g) To engage, through the appropriate networks, with all key stakeholders from the public, private, voluntary and community sectors to facilitate the delivery of area priorities. This will include undertaking regular liaison with parish and town councils.
- (h) To inform, consult and engage local communities in accordance with Council policy and guidance, through the appropriate networks.
- (i) To, as appropriate, respond or refer with recommendations to local petitions and councillor calls for action.
- (j) To make certain appointments to outside bodies as agreed by Council.
- (k) To determine applications for grant aid from the Community Chest, either through Panels for individual Local Area Councils, or through the Panel of Local Area Council Chairs for countywide applications.

(v) the Council's role in encouraging wider access for all to the County's network of public rights of way and other recreational routes.
