
I live close to these premises on Ladywell Way which backs on to this site and would be affected by noise which would inevitably be generated with live music.


I wish to raise objections on the following grounds:

- 1. When the Council moved its vehicle storage facility from the site and sold it to Lawson Fuses for a similar purpose, it put in place a covenant whereby there could be no change of use to site without the consent of neighbouring/adjacent (residential) properties. As the setting up of a licensed premise on the site is a change of use I withhold my wife's and my consent for such a change. I believe a member of your legal department has stated that no such covenant exists. However, it was invoked in the late 1990s and upheld by the Council at that time. I would suggest further due diligence into this is carried out.
- 2. The opening of a licenced premises is out of keeping with the industrial nature of the site/area. It would give rise to increase levels of noise and vehicular traffic. I note the applicant, Mr Findlay, is not seeking permission for an entertainment license (music, dancing etc) and in this he is being somewhat misleading If a alcohol licence is granted, by your own regulations, there is no requirement to obtain separate permissions for any form of entertainment for under 500 persons.
- 3. There is an danger to public safety in as far as there is (and has been for some considerable time) an inadequate policing presence in Ponteland commensurate with the size of the town. The addition of a further licenced premise will add to the risk of crime, disorder, public nuisance and public safety in the area. There are already some twelve hospitality venues in the immediate environs of Ponteland/Darras Hall, of which eleven are licensed.

I hope you will take our objections/concerns into serious consideration when considering the matter at hand.


