#### **01. MEMBERSHIP AND TERMS OF REFERENCE**

**RESOLVED** that the Membership and Terms of Reference for the Ashington & Blyth Local Area Council agreed by Council on 26 May 2021 be noted.

#### **03. MINUTES 10 MARCH 2021**

**RESOLVED** that the minutes of the meeting of the Ashington & Blyth Local Area Council held on Wednesday, 10 March 2021, as circulated, be confirmed as a true record and signed by the Chair.

Mr Paul Jones, Local Services Director referred to the Petition item regarding the asset transfer of public toilets to Newbiggin Town Council and informed the committee that a report had not yet been to Cabinet and would be reported in due course.

#### **05. PETITIONS**

#### **06. LOCAL SERVICES ISSUES**

The Local Services Director and Local Services and Neighbourhood Services Area Manager were in attendance to provide verbal updates about any key recent, ongoing and/or future planned Local Services work and to respond to issues raised by members.

##### **Highways Services**

Mr P Jones, Director of Local Services introduced himself and provided an update as follows:

Risk assessment and methods of working had been reviewed due to the easing of Covid restrictions, with no significant changes in working methods, to ensure safety for employees and public.

The gully emptier was fully deployed dealing with reported issues and cyclic maintenance.

#### **Bridge Refurbishment**

The A189 Klondyke Bridge would be undergoing concrete repairs and waterproofing during the school holidays, week commencing 19 July. Those works would be carried out under contraflow with three weeks north bound and four weeks south bounds. Advance signage and communications would be carried out in advance.

In response to questions, the following information was provided:

- In response to the query regarding the cycle path scheme and possible congestion, Mr Jones explained that he had not seen details about scheme and a formal consultation process would have to be carried out before any improvements. He added that the majority of residents were supportive of the scheme.

- The flow of traffic at the Grand corner was part of the Portland Park development works, with the highways schemes partially beginning through Portland Park. A design review would be carried out to determine the best way forward

## **Neighbourhood Services**

Mr R Wealleans, Neighbourhood Services Area Manager provided an update as follows:

- Residual recycle waste collections continued to go well but new builds were a concern as they continued to stretch services. A review as being carried out.
- The garden waste had also stretched services with perfect growing conditions increasing the weight in grass, and more trips to the tip adding more time to the day.
- A garden waste review would be undertaken at the end of the season to look for efficiencies and make the service more manageable
- There were 569 new customers in the area this year so far and a total of 9918 customers at present in the south east.

## **Grass Cutting**

- Now between cut 6/7.
- Grass cutting proved to be a significant challenge for the teams in the early part of the year.
- There had been a prolonged period of rain which lasted most of May, then very warm weather making the grass grow rapidly
- This presented two challenges – the first was to complete the cutting rounds efficiently to avoid having long and unmanaged grass on view. The second had been the inevitable grass arisings left following the cut of grass which was longer than usual
- It was acknowledged that for reasons beyond control, standard wasn't as high as hoped for during the month of June, but conditions has stabilised.
- Nightshift would be started soon on the A189 for grass, verge cutting and cleansing

## **Weeds**

- Service was being delivered in house again this year
- This year had seen an unprecedented growth in grass and weed around Northumberland with issues within Ashington and Blyth areas
- The in-house approach had worked well in previous years, so the same method would be adopted this year.
- The service was slightly behind where they were last year with weather conditions affecting weed growth creating another challenge
- Blyth had 100% coverage but weeds were starting to show in the areas completed in May/June
- Teams had been out in Ashington carrying out a new trial with weed rippers to remove more stubborn areas of concern along with the pedestrian sweepers with full streeel brushes on cleaning the channels

- There were some issues with Japanese knotweed which were being addressed with specialised treatment
- A second pass on weed killing would be carried out straight away

### **Glyphosate alternative trial**

- A trial of alternative produces was under way county wide in carefully chosen locations
- Results would be analysed and products would either be considered for use of in future or excluded on the grounds of poor performance or prohibitive costs
- The following alternative methods were be trialed:
  - Walk behind weed ripper brush (mechanical with immediate results)
  - Nonanoic acid - colourless oily liquid with an unpleasant smell
  - Pelargonic acid – causes extremely rapid and non-burn down
  - Burning with lance
  - Hot foam
  - Nomix dual – glyphosate based uses less chemicals
- A formal report would be produced at the end of the trial outlining the findings.
- Testing has been carried out on memorials for safety
- Glass recycling on going in Bedlington and to date 578 tonne had been collected throughout the 4 trials areas. The trial was going really well.

In response to questions the following information was provided:

- Haworth Estates and Northern Rail had been informed of the problem of the knotweed along the railway line in Ashington. This would be followed up again when the Parks and Green Spaces Team Leader comes back from leave.
- Residents would not be able to smell those areas that had been treated with Nonanoic acid
- The issues raised by Councillor Wallace regarding excess waste were noted and would be looked into
- Operatives had tried to follow the grass cutters with a strimmer, but this had caused some difficulties. There had been any discrepancies with cuts, but this would be rectified
- A programme of works for gully cleansing was hard to operate as the programme changed with reactive work
- The issue with grass cuttings around sheltered schemes would be taken forward

Thanks were conveyed to officers for all their hard work throughout the difficult challenges.

**RESOLVED** that the information be noted and issues set out in the bullet points above be followed up.
