The licensing objectives are the prevention of crime and disorder, prevention of public nuisance, public safety and the protection of children from harm.

## **Reason for Representation:**

Having looked very carefully at the proposed Application for a premises licence documentation, I want to register my strong objections to the application for the following reasons.

**b) Prevention of crime and disorder** - the addition of a potential 500 - 800 additional people consuming alcohol in the small town centre is a recipe for an increase in crime and disorder. Our Police services are very stretched already and have reduced significantly in the 30+ years I have lived here. The daily presence is almost nil. One only has to see what happens when large groups of mostly younger people, many from outside of Ponteland, congregate in the centre on New Year's Eve. Drunken abusive behaviour, scuffles, fights, some incidents requiring Police intervention, some not, but if that were to happen potentially 7 days a week? This will directly and negatively contravene this licensing objective.

**c) Public Safety** - the additional traffic into Ponteland; the health risks of the undoubted broken glass that will litter the streets (think New Year's Eve), vomit, rubbish etc, each one of these matters poses a real risk to Public Safety. At a time where our community and country are recovering from the COVID-19 pandemic, this is a definite time to put public safety first. In addition, the extra traffic in the area will be considerable and undoubtedly affect air quality and increase pollution. More traffic negotiating narrow streets, pavement parking once again puts Public Safety at risk.

**d) Prevention of Public Nuisance** - all the residents living close to the town centre, including many elderly and vulnerable people, will be subjected to a much greater amount of noise and disturbance than there is now. Music, whether live or recorded playing until midnight will provide a massive nuisance to those in the immediate vicinity of the proposed venue. Thereafter there will be the traffic and people noise associated with hundreds of people arriving and departing the area late at night. Clearly this in itself will be a Public Nuisance.

In conclusion and for the reasons stated I wish to record my formal objection to the licensing application in respect of the proposed new 'Container Village' just off Ponteland Main Street.
