3. I must ensure that my register of interests is kept up-to-date and within 28 days of becoming aware of any new interest, or of any change to a registered interest, notify the Monitoring Officer.

4. Where I have a Sensitive Interest' I must notify the Monitoring Officer with the reasons why I believe it is a sensitive interest. The Monitoring Officer will consider my representations and if they agree they will withhold the Sensitive Interest from the public register. If the Monitoring Office is not satisfied the declared interest is a Sensitive Interest' the interest will be registered in the usual way.

***"Disclosable Pecuniary Interest"*** means an interest of yourself, or of your partner if you are aware of your partner's interest, within the descriptions set out in Table 1 below.

***"Partner"*** means a spouse or civil partner, or a person with whom you are living as husband or wife, or a person with whom you are living as if you are civil partners.

***'Sensitive Interest'*** is as an interest which, if disclosed, could lead to the councillor holding the interest, or a person connected with the councillor, being subject to violence or intimidation
