- (f) Take any steps or further action as a councillor on a matter in which I have a DPI other than referring it elsewhere;

in each case without reasonable excuse, and I recognise any such failure is a direct contravention of the Localism Act 2011 and a criminal offence; and may be investigated by the Police and referred to the Director of Public Prosecutions. I understand that upon conviction a Member or co-optee may be fined up to a maximum of £5,000.

5. If I feel I have an interest which, if disclosed on a public register, could lead to myself or a person connected to me being subject to violence or intimidation, then, with the agreement of the Monitoring Officer, that interest may be considered to be a sensitive interest and the details of that interest will not be included in any copy of the register that is made available for inspection or in any published version of the register.
