The Monitoring Officer will consider my representations and if they agree they will withhold the Sensitive Interest from the public register. **"Disclosable Pecuniary Interest"** means an interest of yourself, or of your partner if you are aware of your partner's interest, within the descriptions set out in Table 1 below.

**"Partner"** means a spouse or civil partner, or a person with whom you are living as husband or wife, or a person with whom you are living as if you are civil partners.

**'Sensitive Interest'** is as an interest which, if disclosed, could lead to the councillor holding the interest, or a person connected with the councillor, being subject to violence or intimidation
